Consent and Release: "Jungle" - May 25 to May 26, 2017

In consideration of the undersigned student (the "Student") being permitted to participate in Jungle 2017 (the "Event"), we agree:

1. The Student will travel to and from an undisclosed location on a bus provided by the event committee. We consent to this transportation on May 25-May 26, 2017.
2. While we do not know the exact location of the Event, we understand its general nature and purpose and consent to the Student's participation in the Event and we understand that (a) the Event may involve voluntary physical activities that may involve risks and dangers of serious bodily injury and/or death ("Risks") (b) these Risks and dangers may be caused by the Student's own actions or inactions, the actions or inactions of others participating in the Event, the condition and layout of the premises and equipment, or the actions or inactions of the organizers; (c) there may be other Risks not known to me or that are not readily foreseeable at this time and (d) losses and/or damages could result from those Risks.
3. We accept and assume all Risks, known and unknown, and assume all liability for the losses costs and/or damages. We release, discharge, and covenant not to sue the organizers of the Event from /for all liability to us and our personal representatives, assigns, heirs, and next of kin, for any and all claims, demands, losses or damages on account of any injury, including, but not limited to, death or damage to property.
4. If, despite this release, we, or anyone on our behalf, makes a claim against any of the organizers of the Event, we jointly and severally agree to indemnify and save and hold harmless the organizers and each of them from any litigation expenses, attorney fees, loss, liability, damage, or cost they may incur due to the claim made against any of the, whether the claim is based on the negligence or otherwise.
5. The undersigned parent signs this Agreement on behalf of the Student. The undersigned Student signs this Agreement on his or her own behalf.

WE HAVE READ THIS CONSENT AND RELEASE, UNDERSTAND THAT BY SIGNING IT WE GIVE UP SUBSTANTIAL RIGHTS WE WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES, AND SIGN IT VOLUNTARILY.
